# HOSPITALITY BOOKING TERMS AND CONDITIONS

## A. DEFINITIONS

**“Agreement”** means the Form and these Terms.

**“CBQ”** means The Commercial Bank of Qatar (Q.S.C.).

**“Client”** means the client in whose name the Form is completed.

**“Form”** means the Hospitality Booking Form to which these Terms are attached.

**“Organisers”** means the PGA European Tour, Qatar Olympic Committee, CBQ, Doha Golf Club and all other suppliers and service providers of the Tournament.

**“Pavilions”** means the hospitality pavilions located at the 18th Green at the Doha Golf Club or the Emperor Pavilion.

**“Terms”** means these Hospitality Booking Form Terms and Conditions.

**“Tournament”** means the Commercialbank Qatar Masters Golf Championship.

## B. COMPLETION AND SUBMISSION OF THE FORM

2. Bookings will only be confirmed when CBQ receives a duly completed Form and full payment of amounts due under this Agreement.
3. Bookings are subject to availability and on a first come first serve basis. Clients who submit the Form and pay amounts due under this Agreement shall take precedence over those who have not yet (i) submitted the Form, and/or (ii) paid amounts due under this Agreement.
4. Cancellation or withdrawal of any booking may only be made in writing. A refund in the event of cancellation is detailed in the Form.

## C. PAYMENT

1. Unless expressly notified otherwise by CBQ, payment of amounts due under this Agreement must be received in full by the person identified at B. 1. above within seven (7) days of the date of invoice. Any failure to pay amounts when due shall deem the Form to be withdrawn by the Client.
2. All payments under this Agreement shall be made in the currency of the invoice and without deduction, set-off or withholding.

## D. HOSPITALITY BENEFITS

1. Access passes for the Pavilions will be provided to the Client (subject to completion of the Form and payment in full of amounts due under this Agreement) 15 days prior to commencement of the Tournament.
2. The Organisers shall make every reasonable effort to provide the hospitality benefits as advertised. Notwithstanding this, the Organisers reserve the right to vary any hospitality

benefits provided that (i) alternative hospitality benefits are not materially different in substance from those originally advertised, and (ii) alternative hospitality benefits shall be of an equivalent value to those originally advertised. In the event no alternative hospitality benefits are available CBQ shall refund the amounts paid by the Client under this Agreement.

3. Hospitality benefits may not be resold or otherwise disposed of by the Client except to invitees of the Client.

## E. CONDITIONS

1. The Client and its invitees must at all times, whether inside or outside the Pavilions, comply with any rules and regulations applicable to the Pavilions and the Tournament as imposed by the Organisers from time to time.
2. The Organisers reserve the right to refuse or revoke entry or access rights of any person to the Pavilions and/or the Doha Golf Club. In so doing, the Organisers shall not be liable for reimbursement of any amounts paid by the Client under this Agreement.
3. The Client may not advertise, by any means, in the Pavilions or the Doha Golf Club. Items for identification purposes only shall be permitted subject to samples of such items being submitted to the person identified at B. 1. above for prior written approval.
4. For the avoidance of doubt nothing in this Agreement shall constitute the Client as a sponsor of the Tournament and the Client shall not be permitted to use the trademarks of, or claim association with, the Organisers or the Tournament.
5. No liability is accepted by the Organisers for any acts or omissions on the part of any supplier, sub-contractor or agent.
6. No liability is accepted by the Organisers for any loss or damage of any nature suffered by the Client or its invitees other than for death or personal injury arising out of the gross negligence or wilful misconduct of the Organisers.
7. The Client shall indemnify the Organisers for and against all claims, costs, demands, damages and expenses (including legal fees) arising due to acts or omissions of the Client or its invitees.

## F. MISCELLANEOUS

1. In the event of cancellation of the Tournament the Client shall be entitled to a refund of amounts paid by the Client under this Agreement proportionate to the number of days the Tournament shall not occur due to cancellation. Such refund shall be the entire liability of the Organisers to the Client and the Organisers shall not be liable for any other costs, loss or damages.
2. This Agreement shall be governed by and construed in accordance with the laws of the State of Qatar and subject to the exclusive jurisdiction of the laws of the State of Qatar.
